## NOTIFICATION UNDER SECTION 25 OF 'RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013'

- 1. Whereas, a declaration under section–6 of the Land Acquisition Act 1894 dated 13<sup>th</sup> December 2012 was published in the Gazette of Arunachal Pradesh dated 18<sup>th</sup> December 2012 as also in newspapers, the last such publication being on 29<sup>th</sup> December, 2012, for acquisition of land required for the development/execution of Simang-II Hydro Electric Project under ADC administrative HQ Boleng, East Siang District.; and
- 2. Whereas, as per section 11-A of the Land Acquisition Act, 1894 the Collector is required to make the Award within a period of two years from the date of the publication of the declaration i.e. latest by 28<sup>th</sup> December, 2014; and
- 3. Whereas, the "Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013" has repealed the Land Acquisition Act 1894; and
- 4. Whereas, section 24 (1) ( a ) of the "Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013" states that -
  - "Notwithstanding anything contained in this Act, in any case of land acquisition proceedings initiated under Land Acquisition Act, 1894,-
  - (a) where no award under section 11 of the said Land Acquisition Act has been made, then, all provisions of this Act relating to the determination of compensation shall apply"
- 5. Whereas, the Award under Section-11 of the 'Land Acquisition Act 1894' (corresponding Section-23 of the 'Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013') could not be finalized so far and is not likely to be finalized by the last date, i.e. 24<sup>th</sup> December, 2014; and.
- 6. Whereas, the Deputy Commissioner, East Siang District, has requested vide letter No. ESD/LM/D-104/2009-10 dated 2<sup>nd</sup> December 2014 to extend the period for Award of land under Section 23 of the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013, in terms of the provisions of section 25 of Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013 and

the Government of Arunachal Pradesh has considered the reasons & justification given therefore, by the Deputy Commissioner, East Siang District; and.

7. Now therefore, in exercise of the powers vested under Section 25 of the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013 read with Section 24 (1) (a) of the said Act, the Government of Arunachal Pradesh hereby extends the period stipulated under section 11-A of the Land Acquisition Act, 1894 for making Award in respect of Simang-II Hydro Electric Project, Boleng Circle, East Siang District, under Section 23 of the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013, by another twelve (12) months, i.e. by 29<sup>th</sup> December, 2015.
